The notice involves: A Public Contract.

The object of the contract is the "Workflow and Document Management Systems and Backlog Scanning for the General Directorate at the Ministry of Economy and Trade in Lebanon in Two Lots" and is divided in **Two (2) LOTS** described as follows:

#### LOT I: Automation of the General Directorate at the Ministry of Economy and Trade

The Directorate General's daily work is based on effective and efficient service delivery of its various departments. In order to enhance the efficiency, performance and transparency of communication, daily operations and decision making at the Directorate General at the MOET, there is a need to develop and implement a system that manages its documents and processes (Workflow and Document Management System).

The Implementation period for **Lot I** is: **Twenty Two (22)** Calendar Months, plus an additional **Two (2)** Months for Operational Acceptance which will be followed by a **Three (3)** Years Warranty.

## LOT II: Backlog Scanning of IPR Unit Documents

The large number of paper transaction files stored at the IPR unit, is increasing, leading to hard management and storage of those hard copy paper documents. Hence, there is a need to scan those files in order to provide the IPR an electronic version of those files easier to store and manage.

Due to the quantity of the hard copy backlog paper documents, and given the fact that these documents are essential to the operation of IPR service, there is a need to scan and archive backdated documents of the fifteen (15) past years (documents dating back to 2003) of 150,000 transaction files totalling to 3,600,000 pages.

The Implementation period for LOT II is: Thirteen (13) Calendar Months, plus an additional Two (2) Months for Operational Acceptance. No warranty period will be applied under lot II.
