# 1.0 Background

This document is the cover document of the 5 main deliverables of the National eStrategy for Lebanon project. The following sections present background material for the project.

## 1.1 ICT for Development/UNDP

This assignment funded by the United Nations Development Programme's ICT for Development Thematic Trust Fund (ICTD TTF) falls within the scope of the first ICTD service line (Elaboration of National ICTD Strategies). This addresses the need for developing countries to design and implement national ICT strategies due to the continuous development potential of ICT and the need to respond proactively to the opportunities and challenges posed by the new global environment.

## 1.2 Office of the Minister of State for Administrative Reform

The Office of the Minister of State for Administrative Reform (OMSAR) is responsible for supervising the implementation of the Government's National Administrative Rehabilitation Program (NARP), a comprehensive program proposing the restoration of functionality to all public institutions in the Lebanese Government. Under the NARP, formal initiatives to mainstream Information and Communication Technology in post-war Lebanon (1991) began.

OMSAR has actively participated and launched various initiatives in support of egovernment attainment over the last six years. OMSAR's proactive role is linked with a close partnership and working relationship with all the key ICT players in the public sector, private sector and academia. Moreover, OMSAR has well-established core competencies in the fields of ICT designs and implementations, modern procurement procedures, and institutional and legal framework developments.

In 2001-2002, OMSAR prepared an eGovernment Strategy working document, which shall be open to discussion with representatives of the various sectors. To complement this effort, it was necessary to develop a National eStrategy for the country as a whole, the subject of this assignment.

## 1.3 Scope of Work

The scope of the assignment is to develop a national eStrategy for Lebanon through a technical assistance consultancy study, undertaken by a Consulting Team.

The following services were requested:

- Draw a situation map for e-readiness
- Draft an eStrategy document highlighting priorities
- Draft a preliminary implementation plan
- Organize and participate in a national consensus building workshop

## 1.4 The Work Plan and Phasing of the Project

The work carried out by the team as part of this project covered 5 phases:

#### Phase 1: Inception Phase

Paves the grounds for the rest of the project and covers preliminary activities. The key deliverable was the Inception Report.

#### Phase 2: eReadiness Assessment

The design and conducting of an eReadiness assessment study for government, private sector and academia.

#### Phase 3: Formulating the National eStrategy

The development and formulation of a National eStrategy for Lebanon was carried out to address ICT policies in 7 major initiatives:

National Policies:	Policies for Closing the eReadiness Gap
National Policies:	National ICT Policies
Sectoral Policies:	Policies for ICT as a Production Sector
Sectoral Policies:	ICT and Human Capacity Development
Sectoral Policies:	ICT for Social Development
Sectoral Policies:	ICT for Economic and Business Development
Sectoral Policies:	eGovernment

Programs, Solutions and Recommendations were identified and developed for the above 7 Initiatives.

#### **Phase 4: Developing Implementation Plans**

A broad implementation plan was developed concentrating on the short term implementation of the National eStrategy. A 6 stage roadmap was proposed.

#### Phase 5: Consensus Building Workshop

The project required the conducting of a single Consensus Building Workshop. However, the Consulting Team started by such a workshop to ensure early acceptance of the project's objectives and scope. During the development of the National eStrategy, the Consulting Team conducted several focus group as well as individual meetings with key stakeholders. The project was completed by conducting another Workshop to introduce the findings of the National eStrategy for Lebanon and to acquire feedback from the stakeholders.

#### 1.5 The Consulting Team

The Consulting Team was made up of 3 persons:

Akram Najjar was the Lead Consultant and was responsible for the following:

- Project management and coordination
- Development of the Inception Report
- Development of the eReadiness phase activities
- Establishing with the team all project decisions
- Selecting with the team all project parameters (Criteria, priorities, issues, etc)
- Formulation and design of ICT solutions and strategies

- Development of the implementation plans
- Development of all content and technical writing
- Involvement with all Consensus Building activities including leading the final workshop

Kamal Siblini was the **Development Analyst** and was responsible for the following:

- Initial planning of the overall project
- Development of the Inception Report
- Identification of eReadiness criteria and assessment of eReadiness
- Carrying out of most activities in Phase 3: development of the National eStrategy that relate to the various national priorities, socio-economic issues and related indicators and measures.
- Clarifying the selection criteria of the various issues
- Assisting the lead Consultant in the formulation of the Implementation plan
- Assisting the lead Consultant in facilitating the workshop

Salam Yamout was the **Data Analyst** and was responsible for the following:

- Collection and consolidation of all documentation
- Conducting all interviews and meetings with stakeholders
- Assisting the lead consultant in the formulation of ICT solutions and strategies

- **Document 3 The eReadiness Assessment**: An analysis of eReadiness criteria for Lebanon based on a survey carried out by the Consulting Team. The survey resulted in a comprehensive eReadiness Assessment.
- **Document 4 The ICT Policies**: The document presents an analysis of the 7 proposed ICT initiatives that meet the requirements of the National eStrategy.
- **Document 5 The Implementation Roadmap**: Proposes a Roadmap for the National eStrategy for Lebanon and discusses related issues such as roles, challenges, critical success factors and implementation best practices.
- **Document 6 Programs, Solutions and Recommendations**: Proposals for around 100 programs, solutions and recommendations are presented in detail.
